#### 2.1 The Award

The Venus International Award is a Certificate. It's a Non-financial Award. It is a Formal Authentication; A Seal of Approval; A Recognition.

#### 2.2 The Scheme

The Scheme has a Policy, Nomination Form, Expert Committee and Judging Process that are governed by the Board of Trust.

This annual award is open to 'Higher Education Teaching Faculty Member' of any nationality, who is in good standing at the time of the nomination, and in the age group of 27 – 70 years with good academic and service record.

The nominee must have completed a recognized Doctorate Degree (PhD) or its equivalent.

#### 4.1 Evaluation Criteria

#### 4.1.1 General

Extensive Knowledge – Mastery of Subject – Creative Thinking and Dedication to Profession – Significant and Sustained Contributions to Institution and/or Community at large – Quality and Competence evidenced by continuing Intellectual Accomplishments and Pursuits

### 4.1.2 Teaching

Innovative Teaching Methodology – Development of a New Program/
Course and Curriculum Design – Transform Traditional Classroom
Communities into Shared Experiences (New Services, Projects and
Activities as a collaborator/consultant) – Research Activity –
Publications (Original Research/Review Articles, Short reports/
Letters, Case Studies/Methodologies and Books) – Invited Lectures /
Presentations – Membership in Professional Organizations

#### 5.2 Criteria

### 5.2.1 Professor of the Year (Code: PY)

Each year since 2020, this award is conferred to a remarkable Faculty Member who have track record of Teaching Excellence and Pedagogical Innovation – Leadership in Faculty Governance – Exceptional Contribution to Theoretical or Applied Research – Championship in Service to Students/Faculty/Related communities – Continued Extraordinary Productivity over the course of career.

The nominee must be above 55 years of age and at least have 25 years of service as on 30 June 2023.

### 5.2.2 Distinguished Faculty (Code: DF)

Each year since 2015, this award is conferred to a remarkable Faculty Member who have track record of Teaching Excellence and Pedagogical Innovation – Exceptional Contribution to Theoretical or Applied Research – Service to Students/Related communities – Continued Productivity over the course of career.

The nominee must be above 44 years of age and at least have 20 years of service as on 30 June 2023.

### 5.2.3 Outstanding Faculty (Code: OF)

Each year since 2015, this award is conferred to a remarkable Faculty Member who have track record of Teaching Excellence – Contribution to Theoretical or Applied Research – Service to Students/Related communities – Productivity over the course of career.

The nominee must be above 34 years of age and at least have 10 years of service as on 30 June 2023.

### 5.2.4 Young Faculty (Code: YF)

Each year since 2015, this award is conferred to a remarkable Faculty Member who have track record of Teaching Excellence – Contribution to Theoretical or Applied Research – Service to Students.

The nominee must be above 27 years of age and at least have 5 years of service as on 30 June 2023.

### 6. CALL FOR NOMINATIONS

The process for VIFA commences with the release of "Call for Nominations".

The 10th Venus International Faculty Awards – VIFA 2024 invites nominations vide F. No. VIF/CFN/FA/2024 opened on 20 December 2023 from eligible "Faculty Member" working in the Institutions of Academic (Autonomous/Affiliated College or University) with a recognized qualification.

### 7. JUDGING

The VIFA 2024 judging is a peer review process. The panel (from diverse backgrounds, working individually) is instructed to score entries from 0 to 100, using the criteria (as mentioned in the section 4 and 5).

- 7.1 The panel aggregates scores and determine the category. The panel decision is final and binding.
- 7.2 For the VIFA 2024, for each category/discipline (Eg. Outstanding Faculty Computer Science) the expert committee will select 2 Nominees. However the Apex Committee reserve the rights to honour less or more than 2 nominees in any category when a nominee meet standards set by the expert committee.
- 7.3 The committee will use discretion if an individual is nominated for two concurrent awards and will move the nomination to appropriate category based on their judgment.
- 7.4 In case, if a nominee meets the criteria for an award, other than the one nominated for, the committee will be deciding to move the nomination to a suitable category.

### 8. SELECTION PROCESS

This section describes VIFA 2024 processes in steps

- Step 1: Screening process (preliminary assessment) of nomination
- Step 2: Acknowledgement intimation to the Nominee
- Step 3: VIFA team may ask proof for credits mentioned in the CV (Optional)
- Step 4: Cross verifying the documents and forwarding it to the committee
- Step 5: Selected nominees will be communicated with an Official Email
- Step 6: CAM 2024 Registration (Refer Annexure B)
- Step 7: Release of the winners list in the Official webpage
- Step 8: An Official Email will be communicated to the Award Winner
- Step 9: Award Presentation Ceremony
- Step 10: Summary of the CAM 2024 will be floated in official webpage

Entry to the venue is subject to complying the conditions and we appreciate your help to make this happen.

#### 1. Entry

- 1.1 The Registered Delegate can collect the VALID ENTRY TICKET from the Registration Desk.
- 1.2 The Guests/Accompanying Persons must have a VALID ENTRY TICKET to enter the Event Hall. The Delegates can get required number of Entry Ticket at the Registration Desk.

#### 2. Refusal of Entry or Ejection
